1. Welcome, Introductions, Review Agenda and Objectives

Kukpi7 Doug Edwards welcomed everyone, territory was acknowledged, and he thanked everyone for their work. Mike Simpson welcomed everyone and introductions were made. The agenda was reviewed and accepted as presented. Note that quorum was only met while Zach Parker was present.

2. Secwepemc Learning Opportunity

Without Secwepemc representation present, Jen informed people that the Secwepemc Landmarks website has information on place names with audio clips of pronunciations. See https://shuswaptrails.com/points/poi/1/

3. Working Group Purpose, Terms of Reference

Mike, Jen and Phil provided an overview of the key points of this Working Group's terms of reference, which are in Appendix 10 of the Shuswap Regional Trails Strategy.

4. Previous Meeting Summary

The meeting summary from January 20, 2023 was approved. Many action items are related to trails initiatives and will be covered later in the agenda. Many are standing items; see table of action items at end of this summary for an updated version.

5. Trails Authorization Requests, Trail Planning and Sub-regional Planning Updates

Kela7scen (Mt Ida)

• Jen and Adrian have been meeting with all Secwepemc governments re: planning, and there have been regular Mt Ida WG meetings. They are making big progress – all councillors from Neskonlith showed up last time. Will meet again in late June.

North Shuswap Parallel Pathway

- Ryan noted that this week received preliminary field reconnaissance (PFR) from Swlax arch dept, key
 recommendation is to do an archaeological impact assessment (AIA) for the entire length of the trail
 Ross Creek Park to Fraser Bay MOTI pullout. No budget to complete AIA, so asked their arch
 department for quote to complete AIA to use as budget indicator for Active Transportation grant
 application submission expected in fall 2023.
- Debbie added that group working on this in NS has launched a fundraising campaign to allocate more funds for the grant application. Setting up a booth every weekend in summer around community for engagement. Funds going through Canada Helps, Shuswap Trail Alliance (STA) to enable tax receipts.

Crowfoot

• Debbie noted she hasn't moved on the January 2023 actions yet. CSRD Electoral Area F Director Jay Simpson had a town hall and Jen was invited to talk about expanding winter recreation. This needs to be framed as how can we all work together in a positive way. Outcome at town hall was good. Representatives from Crowfoot Snowmobile club were there. Chamber, Jay and Shuswap Backcountry Riders will meet – first time Crowfoot Snowmobile Club has expressed interest in working with others, so keep it small to start. Hoping to meet in next two weeks. After that, can reach out to Skwlax leadership, and then engage other recreation groups. Jen is available to help as needed.

Glenemma

• Ryan updated that they've received S.57, it's in place, have met with Marcia re: details and all clarified Working with Lawson Eng to complete final design for trailhead parking area, topo survey completed late 2023, have a final design and Class B cost estimate. And final plan from STA crew to construct the trail. Work to do on decommissioning old trails. Underfunded in terms of budget, Agricultural Land Reserve requires permitter fencing around trail head parking area, extra \$50K cost = and everything else has gone up due to inflation. Funding shortfall. Worst case scenario they don't have funding, defer to 2024. Best case they find the \$100K funding shortfall.

Loftus Lake

• Ryan noted that little to update, waiting for AIA permit to be approved by BC gov, once received the archaeologists can do the work on site, then next steps..

Sorrento Blind Bay Perimeter Trail

• Couple of trail deficiencies noted, may be a small closure to do some fix ups such as packing, will be installing an accessible vault toilet. 95% complete. Well received by community. At Davidson Road in Sorrento/BB, trail is 800m, universally designed. Compact gravel, easy access and mobility.

Reinecker Creek

 Shuffled in priority list, too much on CSRD plate. Had some money for First Nations engagement work, received comments back from some, no PFR requested. Asking for appropriate environmental screening and review. Will look at for future budgeting. There are some expensive items to do (bridges, boardwalk) and STA funding application wasn't successful. Waiting on s.57 from RSTBC and need some discussion with BC Parks.

Mount Baldy (above Sorrento)

• For trailhead itself, will be installing a new vault toilet this year.

Shuswap-North Okanagan Rail Trail (website here)

- Ryan noted that there are four projects based on funding
- Sicamous to Mara section: changed to Sicamous to Km 2-3: 3 main components, rock scaling along Mara Lake, bridge decking, and trail construction km 0-2. Rock scaling tender to be awarded next week, to take place soon in spring. Bridge decking getting engineering drawings, reviewing them, then work with Adrian and team to start decking. Trail construction: not until archaeological investigation completed, working with Splatsin to do ASAP. Project manager working on design work for that section of trail go to tender soon. Jeromy noted that they are doing a feasibility study to do a pedestrian bridge in this section. Ryan noted the trail is officially closed for use by the public.
- Second part: Enderby to Brickyard Road Back Enderby Road: led by RDNO. Archaeological work completed last fall, clear to go. Revegetation plan completed. Project manager is finalizing tender specifications for construction expect to tender in next two weeks.
- Third phase Armstrong to Lansdowne grant funding from BC Active Transportation (MOTI) to construction. Talking with City of Armstrong, lease agreement with CN Rail completed. Project manager and engineering team doing test sections, will then focus on designing tender specifications for this part.
- Still receiving concerns about motorized use in the Rosemond Lake area...reminder to inform
 motorized users please and thank you. Brad noted they're likely not part of an organized group. Phil
 reminded people that this STR Working Group is poised to help with any issues at Rosemond Lake
 (recall it was discussed in recent months/years).
- Fourth project Bigger funding grant to Splatsin is in progress (\$12.5M). Pedestrian overpasses (at Stepney Road and Hwy 97, other at Grindrod) are a possible future phase 2 grant application.

Cliff Ave., Enderby

STA has some self-funding available, some anonymous donations, that STA board is supporting small
communities. Strata development at end of Cliff Ave. City of Enderby helped identify. Built 300m of
recreational and green built trail linking Francis Ave to Cliff Ave, Trevor is doing the building, some STA
staff too. Phase 1 completed this spring. Want to add some crushed gravel cap eventually and a small

retaining wall to get up to Francis Ave. Have a lead on funds for that, it's a good fit for Phase 2. Officially closed, strata development at bottom of trail, their sidewalks and roads will tie in nicely.

Switzmalph Cultural Heritage Trail (nature trail)

- Adrian noted that STA board allocated funding to Switzmalph Cultural Heritage Society, it's an existing
 trail, in disrepair, along foreshore where Salmon River enters the lake. Cultural heritage trail. Commit
 to long term maintenance of the existing trail. Open by invitation (in trail guide and on website) to the
 Switzmalph Cultural Heritage Society, access is First Nations Road. Did some LiDAR mapping, it's
 floodplain and flooded in spring.
- Ryan noted that CSRD did a planting project with SCHS in that are let's make sure we're not disrupting the planted stock (3yr survival needed).

Mallory Ridge

- Eleanor updated folks that they did a petition with overwhelming support for preservation of Mallory Ridge. Waiting for a date from CSRD Electoral Area D Director Tremblay and he will follow up with CSRD board to do a presentation.
- She noted that many moose and elk were observed in the area this past winter.
- Phil did an inventory of social trail system (roughly about 15km), did a draft inventory assessment with mitigation recommendations for it to be a sustainable trail system. The draft is with the Mallory Ridge Community Trails Society now for review, then to pre-review with Secwepemc communities (have started with Splatsin, not others). Have to finish environmental screening. Then will bring up here, and Marcia at RSTBC. Trail system has some sections that are too steep, there is room for steep trails to be a lesser grade. There are two reasonable public access points. Also need BC Hydro and others to look at it (cell tower). Phil assessed types of use as part of inventory.
- Eleanor noted that motorized users use the area, as well as non-motorized.

Skimikin

- Linda noted good news Phase 2 funding came through! Letters of support helped. \$86K for new non-motorized trails. She also applied for small grant from Backcountry Horsemen of BC Shuswap Chapter of BC for seed orchard. Other small funding sources too. Adrian noted pre-work being done later today.
- Sue gave an update on Secwepemc landmarks trail naming they have partnership with RSTBC, they decided to have trail names (not numbers as existed) worked with landmarks project since 2019, had elders site visit for names, had a working group meeting with trail names, went back to landmarks project, took it to Chief Atahm School to be correct translation, and permission to use, and then this spring Libby and Sue met with C&C of Neskonlith, ALIB and Skwlax to present this project and seek their approval. Waiting to hear from last one if it's approved. Then get WG back together again and start getting things together for signage. There will be acknowledgement of the grant, and those people that contributed ideas.
- Jen noted that Motorized rec'd some funds from RSTBC re-route of some existing trails. Trevor noted they'll be doing that soon.

Blind Bay Bluffs

• Patrick noted that WLRA received notification from BC Timber Sales re: proposed logging in the area. It will impact trail system. The WLRA committee will present concerns on safety; other organizations that received this referral will comment separately just on trails.

White Lake

- Patrick and White Lake Residents Association (WLRA) just received White Lake FSR (Forest Service road) relocation just received final road designs, profiles, they will look at that.
- Submitted a parks enhancement program (PEP). Wes DeArmond noted that the PEP grant can be resubmitted, he'll advise when that funding window opens. Wes hasn't heard on FSR road designs; once feedback from Secwepemc governments, they'll follow up.

West Bay Connector

- Jen noted that ALIB submitted 3 applications to federal government for funding, total \$150K, paired with City of Salmon Arm funds and others there is a total \$305K to do the planning, archaeology, environmental, feasibility, etc.
- A request for proposals (RFP) to be issued by and managed by City of SA., to go out in August, work to start in January 2024. Big step forward.

Ribbons of Green (Vernon) – Phil read the following on behalf of Ritchie Leslie:

- "Ribbons of Green is advocating for the completion of an active transportation & recreational trail for cycling and walking between the northern terminus of the Okanagan Rail Trail in Coldstream and the town of Armstrong. Armstrong in turn will be linked to the southern terminus of the Shuswap North Okanagan Rail Trail.
- We've already engaged with the City of Vernon and have active support from the politicians and staff
 we've talked to so far. This week we're are briefing MLA Sandhu and her staff, focusing particularly on
 MOTI engagement and support. Likewise, we are coordinating with the Armstrong Trails Society. We
 are also in the process of engaging with the three concerned municipalities Spall, Armstrong and
 Vernon and will be reaching out soon to the OKIB. Our plan is to schedule a meeting of all the
 stakeholders as soon as possible.
- This will not be an easy or quick project. It will be expensive and complex to route and we've
 identified at least three municipalities, one first nation and the province as key stakeholders. But the
 cyclists in particular will be there as soon as Armstrong is linked to the Shuswap North ORT so we all
 need to be ready for it. Right now, there is no good active transportation or recreational route
 between Vernon and Armstrong."

Sicamous Mountain Bike Park (lower elevation just outside of town):

- Jeromy noted they're trying to get first phase from Owlhead parking lot up and running, it's gone to Marcia at RSTBC
- Adrian noted that this has been entirely funded by District of Sicamous
- Fuel management work has been done in recent years.
- Could consider posting design concept or sharing via email. It will be technical trails, not easy. Hope to tie over to 2 Mile and Sicamous Creek falls eventually.

Larch Hills Nordics - ski trails

- Craig noted that not a lot new to report on Link trail this spring, want to review environmental screening with Adrian, and walk Link trail with Splatsin field technician. Advantage of delay is a rerouting of Catamount Canyon trail too.
- A chunk of private land, active construction of 1.6km of trail with logging happening right now, landowner is donating timber, so it will be cost neutral. Extension of dog loop trails. May be able to continue the dog trails next year.

Shuswap Trail Guide

- Morgan noted trail guide has gone to print, thank STA for the heavy lifting of the project. Printed guides to be available by mid-May. Happy with 2 year publication. Next round in 2 years will be a 4 year shelf life guide.
- Phil said thanks to everyone for their input. Phil noted they included a QR code approach for motorized trails, with links from STA site to all sorts of motorized groups sites.

Funding opportunities

• Current grants available from <u>Plan H</u> include \$5K community connectedness, and \$15K for healthy public policy grants, to engage public, create new policy or amend existing ones. Deadline May 15 but

- extended. Only local or First Nations governments can apply. Anita noted this fund has supported a lot of local things recently.
- <u>Vision Zero</u> grants are aimed at reducing deaths along roads. Contact Anita or Kelly for more info. dd Kelly and Anita's emails for more info. No current funding window will open again in winter 2023/24.
