1. Welcome, Introductions, Review Agenda and Objectives

Mike Simpson welcomed everyone, and thanked Brad Arnouse and Neskonlith for hosting the meeting. Brad welcomed everyone and acknowledged unceded Secwepemc territory. A round of introductions took place. The agenda was reviewed and accepted as presented, with the exception of Jen sharing from her attendance at the World Trails Conference. Early departures were noted.

2. Secwepemc Learning Opportunity

Brad taught us the word swelaps which means big horn sheep, pronounced SHWAY-laps.

3. Previous Meeting Summary

The meeting summary from June 14, 2024, was approved with a minor edit to one of the actions related to the proper use, understanding, spelling and pronunciation of **Y'icwetsutce** and whether it's the right word. Many action items are related to trails initiatives and will be covered later in the agenda. Many are standing items; see table of action items at end of this summary for an updated version.

4. World Trails Conference

Jen attended the World Trails Conference in Ottawa in late September-early October, below is what she shared as key takeaways:

- Gatineaus decommissioning trails bolt logs together
- Climate change sound is silence (less birdsong)
 - Climate change could be the chance to change the thing we have wanted to change for a long time
- Accessibility "nothing about us, without us". Access now app
- Indigenous engagement, look at changing how we introduce ourselves
- Regenerative approach to tourism:
 - 'In the context of tourism what is to be regenerated is the vitality of our places, local people, businesses, community and the complex ecologies that sustain them all.'
 - A trail connects people and communities, fosters a sense of place, and inspires stories.
 - The work of regeneration is fundamentally an ongoing collective practice of creativity and collaborative caring, learning and integrating diverse interests and perspectives, rooted in community and in place.



5. Annual Meeting Planning

The annual meeting is scheduled to be held Wed Nov 20, 2024 from 9AM to 4PM at the Adams Lake Indian Band Conference Centre. Registration link is here and Mike noted there are 41 people registered.

The working agenda was shown on screen, and feedback was solicited on relevant questions and presenters and topics were confirmed. The final agenda will be shared with registered participants a week before the meeting.

6. Trails Authorization Requests, Trail Planning and Sub-regional Planning Updates

Skimikin

- Linda noted Destination BC grant was received, but everything on hold due to election for signage, announcement, etc.
- Localized concern east end seed orchard trail Platt Rd., believe a local individual is moving barricade and changing trails to get firewood. Linda obtained 3 massive concrete blocks, getting them delivered and installed.
- Sue added naming trails project for Skimikin, working with Secwepemc Landmarks project Sept 21 had the unveiling at Skimikin for the signage, had elders present and a celebration. Can be looked at by other groups. Phil noted it looks great out there, lots of education.

Glenemma

- Linda noted amazing staging area, now being deliberately rutted, what is the plan to fix this and maintain it? CSRD just heard about rutting and will have parks contractor to address it.
- Equestrians trying to park, no designated parking for them vs. motorized; need to identify where equestrian trailers should park.
- Will there be an online map of horse trails? Adrian will get Suzanne to put online.

Tsútswecw Provincial Park

- Wes noted about 80% of park and trails impacted 2023 wildfires.
- Met disaster relief funding threshold, engineering assessments completed. Viewing platform now open to public, based on danger tree assessments (DTA) being completed. Plaza area to east is open. It's >\$1M damage. Island loop trail with 4 bridges to replace, and upper flume trail (big impacts, will assess in future) and lower flume trail. Wade Road trail, Gorge and Packer Creek trails, heavily damaged. Geotechnical eye, will be sloughing and tree fall on those trails, will be longer term.
- Scheduled (not guaranteed) for re-opening spring 2025: replacement of bridges, Island Loop trail and lower flume trail, as well as Wade Road/Gorge Road to pictographs.
- Need to think of fall 2026 Salute to the Sockeye event and big crowds.
- Came to agreement with Skwlax te Secwepemculecw about closing for most of a year, keep Wade Road side closed until spring 2025. Ongoing assessments of values and longer term recovery, working with guardians and Interfor.
- Are there good communications? STA getting inquiries about what's open or not. Andrea will
 work with BC Parks communications people to keep website updated.

Sicamous Bike Park

- Adrian noted STA started work, open late 2025 phase 1, 5km of trail, very rocky ground. Starting to plan phase 2 another 10km above phase 1.
- Jamie noted they are working on few other projects met with Richard, Jen Adrian, above
 Bayview linking Sicamous Creek trail. Richard added that best way to move forward with
 Bayview is to get money from District of Sicamous, but a more formal group to apply for other
 funds would be good. Phil suggested don't need a separate group but form a working group of
 multiple interests in the Sicamous.

Reinneker

- STA started work on west trail with approval this spring, built about half, hope to do bridge over winter working on permitting. Adjacent to Herald Bay Provincial Park.
- Question what about "social trails" (unauthorized) that people build and use that contribute to erosion? Adrian and Wes can look at this and create a solution.

South Canoe

Adrian has a s.57 application in to RSTBC to build new trails spring 2025 with BCWS and other
volunteers, above KC (upper extension). There is a South Canoe Working Group, BC Wildfire
Service is a key part of that. BCWS there as they have training ground for rapattack, and as a
memorial to lost member.

Rubberhead

Completed new trail summer 2024, opened in August. Bike Park style jump line, good reviews.

Larch Hills Traverse

Adrian noted planning in the works to build some new sections, one off 109 road and one
connecting Raspberry hill to rail trail. Contract to do preliminary field reconnaissance (PFR)
(archaeological) on those trails is out; no funding confirmed, no s.57 application submitted.

Loftus fen

Adrian and Denise gave an update on this CSRD project to build some trails universal trail 1km along Loftus fen in a CSRD park, it's 90% complete. Denise added that dog park and parking area is 75% complete, a little light on the landscaping. CSRD had grant to build the trail, but couldn't use grant funds for the final aspects (parking, etc.)

Coldstream Ranchland Trail

 Sue noted that the East Vernon hill officially opened Oct 2, 6.3km multiuse non-motorized (horse, snowshoe, walk) trail, west side is moderate, east side is more challenging slopes.
 Central is designated as part of Agricultural Land Reserve, working on parking issues – too tight for a horse trailer. RDNO opened it. Similar problems with dog poop bags, garbage. Working on safe cycling access and connecting to Shuswap and other trails; Coldstream end of rail trail. Info on VOC website and on newsletter.

Shuswap North Okanagan Rail Trail (SNORT) (website)

- Phil noted STA providing technical support to the multiparty committee (CSRD, RDNO, Splatsin)
- Enderby Splatsin pilot section now open, 2km section finished with signage up.
- CSISS contracted to do all invasive species stuff; despite different weed committee in RDNO; did
 a weed pull a few weeks ago.
- 2 pieces near completion (within a month): 4.5km on North Sicamous end, 0.5 to 4.5km; and south of Vernon (1km section active rail CP still owns, ties into line in Armstrong); had to get a lease between railway and Hwy, there is now a chain link fence 6ft high for 1km. It's ugly. That section almost open; closed to north.
- Sicamous end supposed to be open, but connection is Bruhn bridge, closed due to highway construction delays, that will be 2027. The completed 4.5km section cannot be accessed, which is problematic. District of Sicamous and Splatsin are working to get an interim access point. Until

- adequate and safe access, that will remain closed. Exploring pontoons to transport people across lake, acquiring private property. Patience needed.
- More construction happening as we speak another \$12M secured with Splatsin and federal government. <u>Yucwmenlúcwu Caretakers of the Land LLP</u> doing the work, will start construction this month on another 3km on Splatsin IR south of Enderby; some challenges with ALC on ALR and pushback from some property owners. Working on easements to address access to driveways across the SNORT. Spring, construction will continue to 42.6km. Anticipated substantial completion of whole thing by 2026; more sections open next year.
- Jamie suggests there needs to be clear communication to the public about access; they're
 coming a long way to use trail thinking it's open. Completed vs. open! Phil suggested to get
 where people are getting their information from. Rail Trail website and 3 partners have the
 accurate information about what's open. It's a "fake information" issue.
- Thompson Okanagan Tourism Association (TOTA) will have updates linking SNORT to other rail trails to the south

Eagle River Valley Nature trail systems – Andrea

- BC Parks had complaints about access on private property, it's a park, illegal use by motorized
- Andrea and Adrian will connect about this

- Backcountry Horsemen of BC annual raffle now, buy <u>online</u>, \$25K top prize closes Nov 29
- Shuswap Dirt Riders guided ride Nov 2 on Mt Ida, access from Silver Creek, info on website.
- CSISS Jess planning for different funding and grants for whirling disease, hoping to have some FN partnerships. Put link to website, some weed pulls. Contact them for education opportunities for your group.
- Vernon Outdoors Club has bowling at Lincoln Lanes with VOC 6-9pm Vernon check in newletter Friday Oct 18
- Adams River Salmon Society doing walkabout Wednesdays for salmon spawning (but want to minimize numbers, not heavily promoted)

Funding

- Jen noted that **Pacifican** is a funding source, fed-prov, applied in Feb 2024. No word for long time. Finally heard email with questions; filled out spreadsheets of info. Sic MTB park, signs at bike park, and planning funds for Onyx, Scatchard, Kelly Mtn for motorized trails, and South Canoe bike skills parks. \$190K applied for. Hopeful but no word yet.
- Kyra noted that HRSA applied for funds and were successful \$65K. Waiting for final response when the \$ will show up.

Sunnybrae and Garbage Issues

- Barbra noted that they're dealing with garbage, peninsula, FSRs, impacts from Hwy construction
 and difficult to get to transfer station. Seasonal residents and tourists don't know how to access;
 challenging but working with others to address. Bastion Mountain. Some impact from tourism
 with garbage in parks household, furniture, some toxic, may not be local. FSR and access to
 Bastion Mtn and access in parks could signage be put up? Part of solution.
- Impacts of tourism for garbage can it be weighed as a measure of impact? Various points trails, hwy pullouts, etc.
- Is there an opportunity to use weight of garbage as a metric to measure impact of tourism?
- Frank noted that this is reactive not proactive. Adrian noted they've discussed this with Kevin E at RSTBC, slow. End up doing it yourself. Denise noted they've added some signage on garbage cans. Otherwise it's a bylaw complaint. Adrian noted a different experience with transfer station in RD of Bulkley Nechako. Barbra added signage but also messaging to tourists, trying to change human behaviour. Linda noted "leave no trace" principles are not being utilized to most effective value. Recognize that some of those dumping garbage won't likely read signs or care about messaging; but others want to do the right thing.
